
What is a **Qualifying Move?**

A move made under the following conditions:

- due to economic necessity,
- from one residence to another,
- from one school district to another, and
- within the past 36 months

What is **Qualifying Work?**

New temporary or seasonal employment or personal subsistence in the production or initial processing agriculture or fishing products

Trabajo temporal or por la temporada, o para subsistencia personal, en la produccion o procesamiento inicial en agricultura o pesca.







Josue tells you he moved from Texas to Louisiana in January 2020 to find work. He then tells you he worked the fields harvesting sugar cane in August 2020.


Is Maria a Migratory Qualifying Worker?

Maria has lived in Tangipahoa Parish her whole life and worked seasonally every year picking strawberries. This year, she moved from Tangipahoa to Livingston Parish and began working in the strawberry season the next week.
